### Procedure:

Give phase A into a clean and disinfected glass beaker , sprinkle xanthan gum into it and stir with high speed . Heat phase B in separate glass beaker to 150F/66C. Add phase B to phase A and stir until homogenous. After the temperature has cooled to 100F/40C add phase C to A/Band stir again.
