Procedure:

Heat products 1 to 8 & 12 at 75 to 80° C, mix the products 9, 10, 11, 13, 14, 15, 17 & 18 (except the perfume) separately and agitate at 45° C. Mix at high speed the two phases, oil and water. Cool to 28 ° C to add perfume/scent 16. Wait until room temperature for packaging.
