2	<u>INNOVALOE ALOE VERA GEL 200:1</u>	1.0
3	Sodium lauryl sulfate	16
4	Polyoxyethylene (20) sorbitan Monolaurated-	1.5
5	limonene	10
6	Polyacrylic acid	0.4
7	Acrylic copolymer emulsifier	0.5
8	Butylated hydroxytoluene	0.1
9	Triethanolamine	2.0
10	Polyalkyleneoxide-modified	0.5
11	polydimethylsiloxane Disodium EDTA	0.2



Procedure:

While heating the water to 75-80°C add the Aloe Vera and stir and add the aqueous phase, ingredients from 3 to 5. Separately the oily phase at 50-60°C, mix slowly 6 to 10. Mix both phases while stirring and maintaining temperature between 60 and 70° C add the preservative (Disodium EDTA) at the end and let cool at room temperature after it's free of lumps.
