6	Sodium benzoate	1.50
7	Dye	0.50
8	Perfume	0.50



### Procedure:

While heating the water to 75-80°C add the Aloe Vera and stir, add ingredients 2 to 4 with constant mixing. Mix well after each ingredient has been added until the batch gets clear and homogenous and let cool at room temperature. At the end add the ingredients 6 to 8 in order and mix until the batch gets free of lumps and/or particles.
