| 1 | Cocamidopropyl Betaine | 3.0 |
| 2 | Vegetal oil | 15.0 |
| 3 | Coconut oil | 20.0 |
| 4 | Sodium Lauryl Sulfate | 3.0 |
| 5 | Palm kernel oil | 5.0 |
| 6 | Cocoa butter | 5.0 |
| 7 | Sodium chloride (10% aq sol) | 1.0 |
| 8 | Sodium hydroxide (50% aq sol) | 41.0 |
| 9 | Glycerin | 3.0 |
| 10 | <u>INNOALOE ALOE VERA GEL CONCENTRATE 20:1</u> | 3.0 |
| 11 | Dye (oil base) | 0.5 |
| 12 | Perfume | 0.5 |



PROCEDURE:

1. In a vessel heat between 75 – 85°C the ingredients 1 to 6 mixing at medium speed
2. In a separate vessel mix the sodium chloride and the sodium hydroxide at room temperature and medium speed.
3. By contact method in a contact tower of Mon Savon, the mixtures of both vessels are mixed by contact, obtaining a paste that is soap and water and glycerin as waste.
4. In a separate vessel put glycerin at 45-50°C mixing at medium speed the INNOALOE ALOE VERA GEL JUICE 1:1. Once is grump free ix the oil base dye and perfume.
5. Melt the soap paste between 40-45°C and mix the vessel with the glycerin, INNOALOE ALOE VERA GEL JUICE 1:1, dye and perfume.
6. Proceed to cool to pack (Either by molding or compression)
