11	Fatty acid amidoalkyl betaine (TEGO-betain ZF (30% solution))	5.00
12	Glycerin (96%)	13.00
13	Sorbitol Solution (70%)	15.00
14	Flavor	0.80



Procedure:

While heating the water to 75-80°C add the Aloe Vera and stir, mix the rest of the ingredients in order and agitate at maximum available shear. Mix until fully hydrated.
