7	Bleached lechithin	4.6
8	Hydroxyethyl cellulose	1.6
9	Flavor (e. gr., lemon)	1.0
10	Sodium saccharin	0.3
11	Sodium monofluorophosphate	0.8
12	Deionized water	21.5
13	<b><u>INNOALOE ALOE VERA GEL CONCENTRATE 10:1</u></b>	0.50



### Procedure:

While heating the water to 75-80°C add the Aloe Vera and stir, mix the rest of the ingredients in order and agitate at maximum available shear. Mix until fully hydrated.
