Procedure:

1. PART A: a) Dissolve Disodium EDTA in Deionized Water with mixing. Mix until dissolved. b) Sprinkle Carbopol® * Ultrez 20 Polymer on surface of Deionized Water and allow powder to wet-out. Mix until uniform. c) Add ingredients 4-5 with mixing. Mix until uniform.

2. PART B: a) Neutralize batch to pH 5.9-6.3 with Sodium Hydroxide (18%). Mix until uniform.

3. PART C: Add PART C ingredients to batch in order with rapid mixing. Mix until uniform.
