13	(Nipasol) Silicon DC-200-350 CK-S	1.0
14	Tween No. 20 (Arcoten 2)	0.5
15	Blue ultramarine pigment C-17	7.0
16	<u>Aloe Vera juice 1X</u>	3.0
17	Titanium dioxide	3.0



Procedure:

Mix products 1 to 6, 16 & 17 at 60° C. Mix separately 7 to 15 at 85° C. Blend the to mixtures at high speed. Wait to cool at 23 to 25° C to pack.
