| 4 | Tenox B. H. A. | 0.2 |
| 5 | Tegosep P. (Propil paraben) | 0.2 |
| 6 | (Nipasol) Black pigment (Ivory Blak) | 12.0 |
| 7 | Flock Negro | 4.0 |
| 8 | Alico No. 9 (Naftal 170-25) | 53.0 |
| 9 | Aloe Vera juice 1X | 0.5 |
| 10 | Aluminum stearate (Altogel) | 2.0 |



Procedure:
Mix the ingredients 1 to 7 at 85° C. Then cool down to 65° C to add 7 to 10
