16	Red pigment No. 19 D y C 7029	0.010



### Procedure:

Mix 1 to 3 at room temperature. Separately mix 4 to 12 between 70 to 80° C. Mix 13 to 16 at 45° C. Blend all mixes and wait room temperature to pack
