7	Crodamol IPP (Isopropile palmite)	12.0
8	Squalene	2.0
9	Aloe Vera juice 1X	3.0
10	Tegosep P. (Propil Paraben) (Nipasol)	0.1
11	Propilen Glicol	5.0
12	Solid white grease(Petrolato PJ BCD)	12.0
13	Anhydrous lanolin (Lindalan X)	1.0
14	Biopure-100 (Imidazolidinil Urea)	0.3
15	Trietanolamine	2.5



Procedure:

Mix ingredients 1 to 8 at 45° C. Separately mix 9 to 14 at 90° C. Blend both mixtures at high speed. Wait til room temperature to pack.
